# **DIRECTIONS TO JFK AIRPORT–CARGO BUILDING 77**

## **BY CAR**

### **FROM MANHATTAN/BROOKLYN**

Take Belt Parkway East to the Nassau Expressway. Stay on left and follow the Nassau Expressway to the end (follow signs to North Boundary Road). Make right turn at light. After right turn, make left on to North Boundary Road at next light. Travel along North Boundary Road but stay in the right lane. Follow signs to Building 77/Cargo Area D. After you pass the Mail Facility (Building 250) and the US Post Office, you will see a large green sign directing you to Building 77. Turn right at stop sign on to Eastern Road. After you make the turn, continue along Eastern Road. You will see a large green building near the end of the road. That building is Building 77. Turn right into the parking lot.

**Please use the unmarked parking spaces.**

### **FROM VAN WYCK EXPRESSWAY**

Take Van Wyck to Nassau Expressway, then follow the instructions from Brooklyn.

### **FROM LONG ISLAND**

Take Belt Parkway West to Farmer's Boulevard/Guy Brewer Boulevard exit. At light, turn left (cross over parkway). Stay on Farmer's Boulevard. At next light make a left on to Guy Brewer Boulevard. Stay on Guy Brewer to Rockaway Turnpike. After crossing Rockaway Turnpike and entering the airport, turn left at next light. Follow signs to Building 77/Cargo Area D. After you pass the Mail Facility (Building 250) and the US Post Office, you will see a large green sign directing you to Building 77. Turn right at stop sign on to Eastern Road. After you make the turn, continue along Eastern Road. You will see a large green building near the end of the road. That building is Building 77. Turn right into the parking lot.

### **FROM NEW JERSEY**

Take New Jersey Turnpike South to Exit 13, Goethals Bridge. Take Goethals Bridge to Staten Island Expressway (278) to Verrazano Bridge. Verrazano Bridge to Belt Parkway East. Follow the instructions from Brooklyn.
