


SEIZURE AT TWO FACTORIES NAMED "BORDADOS GASSERC"

Santa Cruz de la Sierra, Bolivia.


A TikTok video led to the discovery of 'BORDADOS GASSERC" – an account with 6779 followers - a factory in Santa Cruz de la Sierra that specializes in embroidering caps and clothing with various brand logos, supplying local informal markets. The factory operates two branches and requires a minimum order of two dozen items, suggesting high production volumes. We filed a formal complaint and coordinated raids on both locations.

We discovered in both brands machines, fabric, unembroidered caps, finished products of several brands, including **NIKE**, **LACOSTE**, **MLB**, **NEW ERA**, **POLO RALPH LAUREN**, **ADIDAS**, **PUMA**, **COLUMBIA**, **BURBERRY**, **SUPREME**, **CONVERSE**, **HARLEY DAVIDSON**, **VANS**, **UNDER ARMOUR**, **DC COMICS**, **VERSACE**, **PRADA**, **TOMMY HILFIGER**, **GUCCI**, **WWE**, **THE NORTH FACE**, **LEVIS**, **CHANEL**; and over 15 workers, including a child. All items, including computers and logos, were seized and transported to the FELCC wharehouse, and the machines were sealed.











RELEVANT CASE IN COLOMBIA

MARIA BENDITA STORE

We found a profile in Instagram called 'Maria Bendita' showing stores in two Shopping Malls, selling suspicious products bearing PANDORA trademark.

We proceeded to investigate the "Maria Bendita" stores located at the Viva and Primavera Urbana Shopping Malls in Villavicencio. No Pandora products were sold at these locations; however, the saleswoman informed us that the products were sold at a nearby store. Based on this, we visited the store she mentioned, confirmed that counterfeit products were being sold, and made a purchase to obtain evidence.

Accordingly, we proceeded to send a C&D letter to the infringer. After this, the infringer contacted us, and currently we are negotiating an agreement whit the infringer.











VIRTUA FX STORE. CASE IN MERCADO LIBRE



Monitoring the Mercado Libre platform, we found a profile called "VIRTUA FX" that sold audio converters. The product description mentioned that the product had DOLBY audio output.

We proceeded to investigate the seller, considering that Dolby does not manufacture this product nor does it contain any license.

Accordingly, we proceeded to send a C&D letter to the infringer. After this, the infringer contacted us to sign an agreement with us committing not to sell these products anymore and to destroy all the products he had for sale.

We rank platforms based on:


1 - Takedown speed

Medium (~48h), effective technical process, medium commitment



Variable (can take a week), less transparent process, medium-lo commitment



Slow, limited mechanisms, low commitment



As an emerging platform – surprisingly fast, strong IP commitment



RECOMMENDATIONS FOR PLATFORMS



Establish easy-to-use and multilingual reporting panels

Respond within 72 hours as an industry standard

Set up direct channels with legal firms or rights holders

Publish enforcement and transparency statistics

IP trained staff
